



## 21 Station Road, Barnes London SW13 0LF

### Location

The premises are prominently located overlooking Barnes Green on Station Road, close to the junction with Barnes High Street and Church Road. Barnes Green is centred around Barnes Pond and connects to Barnes Common, which extends to the River Thames. The area is an affluent London village with a large residential catchment and is easily accessible via Barnes Bridge or Barnes Stations. 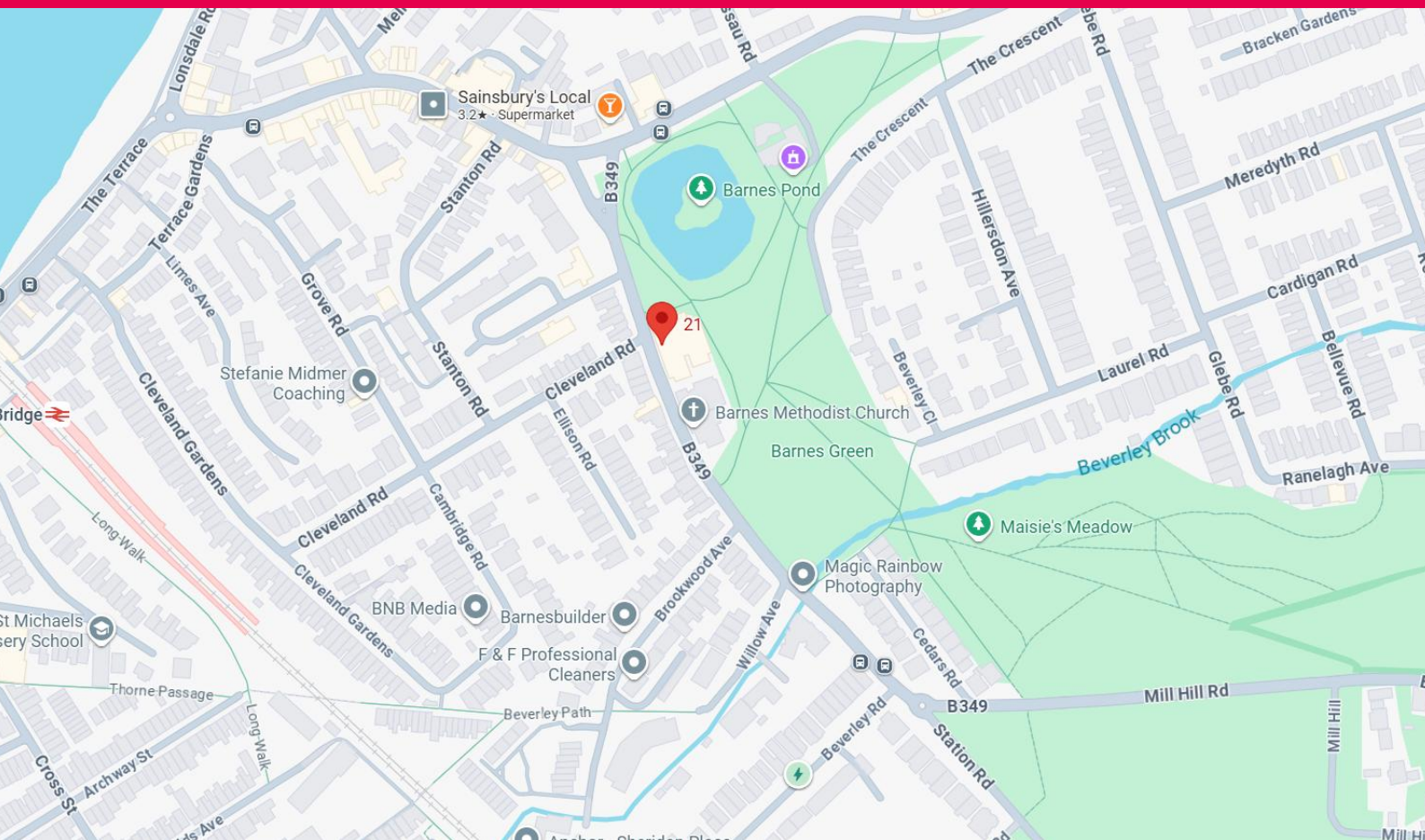
